

**CSPP Board Meeting**  
**May 4th, 2019**  
**8:30am-9:15am**

**I. Vote to Approve Previous Minutes**

Ellen Nasper moved to approve the minutes from the board meeting on March 16th, and Elaine Hunter seconded the motion. Barbara Marcus and Andrew DiFiore abstained. The minutes were unanimously approved.

**II. President Elect**

Carrie Christensen informed the board that the Ad Hoc President Elect Committee met with several potential candidates for the position. The committee decided to nominate Ryan Ochoa. They felt that he was a very strong candidate based on all the work he has done as representative of the Hartford Region, his strategic thinking, his strong level of commitment to CSPP, his work on the Scholarship Committee, on the Early Career Committee, and on university outreach. Carrie moved to approve Ryan as President-Elect, and Donna DiCello seconded the motion. Dean Leone abstained, and the motion was unanimously approved.

**III. Early Career Strategic Plan**

Donna DiCello presented her Early Career Strategic Plan. As she explained, the University Outreach Committee will be working with the Early Career Committee. Starting in the fall, the University Outreach Committee will reach out to Yale, Southern, UNH, UConn, and The University of Hartford to spread the work about CSPP. There will be an effort to integrate Early Career members by identifying them at clinical conferences and grooming them to become board members. Donna has plans to introduce a new scholarship for an Early Career member to attend a Division 39 conference. As she said, the mentoring program will continue as it has been. Elaine Hunter is starting an Early Career peer supervision group. There are also plans to have some mini meetings geared specifically towards areas of interest to Early Career members. Donna spoke of the need to get the general membership involved with mini meetings, not just board members.

**IV. Nominating Committee**

Carrie Christensen spoke about altering the role of the Nominating Committee to have more of a focus on succession planning. She reported from the Division 39 conference that in meeting with

local chapters, she learned that most local chapters are focused on succession planning. Several chapters that have not been focused on succession are closing. Carrie moved to adopt a new version of the Nominating Committee, and Ellen seconded the motion. The committee will work on identifying new members and their interests, grooming members for board work, and developing a pool of potential candidates for board positions. Elaine Hunter suggested giving the committee a budget so they would have leeway to plan events. The motion was unanimously approved.

## **V. Registrar**

Carrie Christensen reported that Christine Meyer is interested in being Registrar. She is an Early Career member, though this is her second career. Christine has indicated that she would prefer not to be on the board. Carrie proposed changing the Policies and Procedures so that the Registrar is not a board position. As she said, this would be a way of reducing the size of the board. Historically, this has not been a board position until recent years. Carrie moved to change the Policies and Procedures, and Dean Leone seconded the motion. There was a discussion about the need for communication between the Registrar and the Clinical Conference committee. It was suggested that the Registrar could report regularly to the Clinical Conference Chair. Carrie indicated that at the fall retreat, we can address where the Registrar falls, as far as who she reports to. The motion was unanimously approved.

## **VI. Board Meeting Times**

Elaine Hunter said that she talked with Cindy Kissin, the board's consultant, and that Cindy had some thoughts about board meeting times. Elaine suggested postponing a vote on board meeting times until the Fall retreat once the board has read Cindy's report. There also was a question of whether to have a board meeting before the clinical conference on September 28th, since the retreat will be just one week prior. Carrie suggested that they see how productive the retreat is, to determine the need for a board meeting on September 28th.

## **VII. Recognitions**

Carrie Christensen spoke about how the board has changed a great deal in recent months, with a lot of turnover. She expressed appreciation for the support the board has given her and passed out a gift to each member, as a token of her appreciation. She acknowledged and thanked those who are leaving the board: Matt Brennan, who served as Registrar for 1 year; Donna DiCello, who served as President-Elect for 1 year, will continue working on the Early Career Initiative, and is co-leader of the Racialized Experience Study Group; Elinor Kotchen, who was the Recording Secretary; Ashley Clayton, who is the Newsletter Editor and is involved with the Early Career Initiative; Rachel Torello, who served on the board for 9 years in various positions, including as President and Scholarship Committee Chair, and who brought in a lot of Early Career members; and Mickey Silverman who served on the board for 13 years, as Newsletter Editor, part of the

Long Range Planning Committee, and first honorary board member, and who will continue to be involved in some Fairfield County events.

Carrie Christensen welcomed everyone to the Open Meeting. She introduced Ryan Ochoa, the newly elected President-Elect. The board members then introduced themselves, followed by the other attenders. During the introductions, Angelica Kaner spoke about the joint conference between CSPP and WNEPS, which will be held on November 2nd.

Carrie outlined that there would be 30 minutes for discussion. She posed the question, “What do you like about CSPP?” People cited the exciting conferences, the way CSPP focuses on the intersection between American culture and psychoanalysis, the opportunity to connect with other professionals, the listserv, and the community that CSPP fosters.

Carrie then asked, “What does the board not know?” There was a discussion about the disconnect between the board and the general membership, and some members feel that the board has no transparency. Someone suggested that the minutes could be sent to the membership. A few attenders expressed uncertainty about how the board works. Wendy Stewart talked about how the board has hired a consultant to advise it on how to recruit new members. There was a suggestion that the board could put more information on the website.

Carrie’s next question was, “5 years from now, what would CSPP look like?” Several people spoke about the need for more diversity, on both the board and amongst the membership. They encouraged the board to think about why there are not more people of color, but also why it wants more diversity. The need was raised to think about what psychodynamic thinking is and how it informs how we interact with the world. As a few people pointed out, CSPP needs to think about how its principles apply to other settings, as psychodynamic ideas do not necessarily have to apply only to private practice. Someone suggested that the NHLC is not the most welcoming place to hold clinical conferences, and CSPP needs to think about the image it is projecting. A board member spoke about how Division 39 is working on all these issues and how we need to ensure that CSPP is plugged into what Division 39 is doing.

Carrie thanked everyone for attending.

### **LRPC**

Over the past few years we have been trying to address the difficult issue of how to bring about new leadership, how to attract younger people to the Board and future leadership. (As an aside, because this task has been too big for us to address successfully along with our other tasks, I welcome the newly proposed Committee

and envision it complementing our work.) We have had many discussions on why younger and/or newer members have been leaving the Board(4/11/18 and 11/6/18) and addressed the frustration expressed by those members re: how we go over matters over and over in a "nitpicking way" and recommended to the Board that the work be done in the committees with proposals being brought to the Board with the President placing time limits on each agenda item (as urged during both my tenure and Elaine's). Also, we addressed the frustration expressed re interpersonal dynamics by recommending that unpleasant comments be addressed immediately during the meeting and/or that the President (or designee) have a discussion with the person(s) after the meeting.

Other examples of our work over the past few years have been to revise P&P, discuss whether to expand CSPP's mission to include promoting social justice, formalize a back-up system for some key positions, develop a system of coordination of communications by ultimately proposing that that be a role of the President-Elect, new recommendations to the Board re welcoming new members, a proposal to establish a Scholarship Committee; a proposal to have an E-communications Committee to oversee the electronic communications; a proposal to formalize a back-up system for key positions. All of these proposals and more were made to the Board, passed and implemented.

### **Historian Report**

The role of the Historian is to provide the President and the Board with a historical perspective on current issues that the Board is facing, advise the Board concerning the By-Laws and Policies and Procedures as they effect Board functioning, update the Policies and Procedures document as changes are made and send the new version to the Website Manager and maintain an Archive.

Description of Event – Meetings were developed as part of increasing activity within the Hartford Region of CSPP. Meetings were held in public areas (e.g., Starbucks) where members networked with other CSPP regional members and discussed what events they would like to see and be inclined to attend. A variety of suggestions were provided, including (but not limited to) 1) an ongoing study group focused on reading selected works rooted in psychoanalytic theory and clinical practice, 2) clinical lectures related to understanding substance abuse through a psychodynamic/psychoanalytic framework, and 3) a consultation group for providers who provide neuropsychological/psychological assessment within their practice.

### Clinical Presentation – March 23, 2019

“Psychodynamics of Addiction: Treatment Within a Harm Reduction Model”

Presenter – Dean Leone, Ph.D.

Description of Event - This presentation offered an overview of the psychodynamic contribution to understanding addiction with a specific focus on the role that shame and unhealthy attachment patterns play in addiction. How these patterns interfere with recovery were reviewed and discussed. The Harm reduction model, as conceptualized, provides a common-sense approach that helps an individual with

substance use issues gradually relinquish maladaptive defenses that are meant to reduce the negative consequences associated with addiction.

#### Future Events (Tentative)

- Consultation Group for Neuropsychological/Psychological Assessment

There has been discussion about holding the first group meeting in June 2019, but this is dependent on level of interest. Odds are the group will not start until the Fall 2019 when it is likely members will have more interest in attending. The plan for this group is to meet once a month, and to discuss clinical cases that include administration of psychodiagnostic instruments and development of a comprehensive evaluation. Discussion may also occur around how to administer select instruments or utilize specific scoring programs (e.g., Rorschach R-PAS, Wartegg Drawing Completion Test). The purpose of this group will be for members to receive feedback and suggestions from peers who commonly incorporate psychoanalytic/psychodynamic principles in their clinical work. Due to most of the interest being from providers within the Hartford area, this group will function as a regional event. If further interest is generated from members outside of the Hartford area, we will evaluate the potential for this group to be held in a different location.

- Minimum of Two Clinical Presentations for the 2019-2020 Academic Year

It is the goal of the Hartford Region to hold one clinical presentation during the Fall of 2019 and another presentation around March/April of 2020. Over this summer, dates of these events will be established along with recruiting presenters. Such CSPP members as Mary Daly, Psy.D. and Pamala McGuire, Ph.D. have informally expressed interest in delivering a presentation to the Hartford Region.

- Coffee & Conversation Meetings

The region will continue to hold Coffee & Conversation meetings on a regular basis. Based on this year's response and attendance, meetings will likely continue to be held at public setting in West Hartford. Consideration will be given to continue holding meetings in Glastonbury (attendance has been much lower in comparison). Holding future meetings in different locations (e.g., Middletown, Windsor) will be dependent on level of interest from regional members.

- Peer Study/Reading Group

Developing such a group (similar to what Michael Kahn facilitated for the past several years) has been discussed, but no immediate plans to establish and hold meetings has been yet established. It is expected that if such as group was developed, meetings would occur either on a biweekly or monthly basis.

We have decided that the focus will be 2-fold:

1) Dr. Otto Kernberg will begin by identifying levels of narcissism from the most overt and destructive expressions to its more subtle forms and then differentiating the kinds of transferences that typify these levels.

2) Drs. Diamond and Yeomans will present clinical examples of how to work with the challenges these issues present to us in everyday practice using the Transference Focused Psychotherapy (TFP) that their group has researched and developed.

3) Jill Delaney, a member of their study group, has graciously agreed to be our moderator.

Regarding format, while we are still honing the details of format and timing, we are planning to leave ample time for interactive discussion, coffee/breakfast, and a lunch to follow.

As we have with past joint programs, we will host the presenters the Friday evening (November 1) before with a dinner for executive board members. Details to follow.

#### Current Challenges and Future Plans

Our current challenge is Board succession. We have made to plans to address this by forming a committee specifically to engage members around participation and involvement with our Board.
